General Information

Sports Car Club of America, Incorporated bylaws (effective July 1, 2000)

Section 2. Purposes. The nature of the activities to be conducted and the purposes to be promoted and carried out are as follows: To promote interest in sports cars and other fine automobiles and to encourage their safe and skillful operation, by developing, arranging and regulation closed circuit road racing, rallying, and other forms of automotive competition by dissemination of information through news releases and Club publications, and through related social recreation activities for the instruction and enjoyment of its members.

Section 5. Exempt Organization. No part of the net earnings of the Club shall inure to the benefit of, or be distributable to, its members, trustees, officers, or other private persons, except that the Club shall be authorized and empowered to pay reasonable compensation for services rendered and make payments and distribution in furtherance of the purposes set forth in Article 1, Section 2, hereof. No substantial part of the activities of the Club shall be the participation in, or intervention in (including the publishing or distribution of statements) any political campaign on behalf of any candidate for public office. Notwithstanding any other provision of these bylaws, the Club shall not carry on any other activities not permitted to be carried on by a corporation exempt from Federal Income Tax under Section 501 ©(4) of the Internal Revenue code of 1986.
